

Zarzamora Prímo Route 103


- Starting service on the Zarzamora
 Prímo Route 103
- From Madla Transit Center to Crossroads Park & Ride
- Operating seven days a week
- Service Hours: 4:00 a.m. to 1:00 a.m.
- 12-min service from 6:00 a.m. to
 6:00 p.m.
- 30-min frequency from6:00 p.m. to 1:00 a.m.
- Bus Stop Balancing




Why is Bus Stop Balancing Important?

- Closely spaced stops result in slower travel times
- Adjusting stop spacing will provide improved travel time

Bus stop balancing example:





672 Southwest Circulator and 95 Extension

672 Southwest Circulator

- Proposed new route
- Provide service from Madla Transit Center to Palo Alto College, Texas A&M San Antonio and the Southwest General Hospital
- Operates seven days a week
- 30 minute frequency
- 95 Extension
 - The proposed Route 95 changes will now service the South Texas Medical Center
 - Provide local service from Crossroads to Medical Center Transit Center
 - Operates seven days a week until 10:00 p.m.
 - 30 minute frequency



City of San Antonio Partnership Service Improvements: Phases I, II, & III

What Have We Seen From Phases I & II?

Phase I Improvements (January 2018):


- Improved frequency (30 minutes) on nine routes.
- Improved frequency (12 minutes) on routes 20 and 26.

Phase II Improvements (May 2018):

- Improved frequency (12 minutes) Routes 3, 24, and 76.
- Route 24 extension to Centro Plaza.

Phase III Improvements


- Routes 82 (Culebra) and 88 (Bandera)
 - Improve frequency to 15-minute from 20minute frequency from 6:00 a.m. to 6:00 p.m. Monday thru Friday
 - Routes 82 and 88 from 5 Points to 24th Street: 8 minute service
- Routes 43 (Flores) and 44 (Pleasanton)
 - Improve frequency to 20-minute from 30-minute from 6:00 a.m. to 6:00 p.m. Monday thru Friday
 - From Martin & Navarro to S. Flores & Pleasanton: 10 minute service



Additional Service Revisions: Route Renaming and Re-Pairing

Reclassification of Prímo 101

- Reclassify Primo 101 to 501 UTSA/Leon Valley Crosstown
- Reclassified to align with the standard of service provided
- Same schedule and frequency



Additional Revisions

Routes Considered for Re-pairing – Summary of Changes

- To better match frequencies and ensure efficiencies
- Route 79 would no longer serve Centro Plaza, Route 70 will now serve Centro Plaza
