#### Statement to Public Regarding VIA Virtual Meetings

This special joint budget workshop videoconference meeting of the VIA Metropolitan Transit Board of Trustees and Advanced Transportation District Board of Trustees (collectively, "Board") will be conducted as an audio/videoconference meeting (only) at 3:00 p.m. on Tuesday, August 3, 2021. In keeping with proper social distancing measures in order to slow the spread of COVID-19 and avoid meetings that bring many people into congregate settings, the Board will not meet in person. Instead, this videoconference work session will be conducted pursuant to the Texas Open Meetings Act as temporarily modified and suspended by the Office of the Governor on March 16, 2020 in response to the COVID-19 pandemic and associated declarations of emergency.
