#### .03 DISCLAIMER NOTE:

Service as a Special Assignment Designee is performed on a voluntary basis and entitles the employee to be responsible as subject matter expert in that area of assignment and does not entitle the employee to any benefits normally associated with a sworn officer of a higher rank. The designation of an officer as a Special Assignment Designee is considered a secondary responsibility to basic peace officer duties, i.e. patrol duties. The Special Assignment Designee serves at the direction and appointment of the Chief of Transit Police and may be altered or terminated at any time by the Chief of Transit Police. Hours worked as a Special Assignment Designee are solely compensated as straight time in lieu of normal patrol duties or as overtime only upon pre-approval of the Chief of Transit Police.
