Chief Witherell,

In compliance with Texas Best Practices section 6.10, the Best Practices program manager is tasked with completing an annual analysis of use of force. I have completed the analysis for all 2022 uses of force by Transit Police Officers and Transit Security Officers.

In 2022, there was a total of 63 uses of force. (in 2021 there was a total of 109 uses of force)

I have broken down this total into the following 6 categories:

- Physical Force 17
- Baton Display 1
- Taser Display 26
- Taser Deployment − 12
- Firearm Display 6
- Firearm Deployment 1

Each of the above-listed uses of force were investigated by the appropriate supervisor and there were no findings of improper or excessive use of force.

As in previous years, there are a few locations where multiple uses of force occurred.

- Centro Plaza 10 uses of force
- Kel-Lac Park and Ride 3 uses of force
- Randolph Park and Ride 2 uses of force
- 1021 San Pedro 2 uses of force
- Crossroads Park and Ride 2 uses of force
- Madla Park and Ride 2 uses of force
- Brooks Park and Ride 2 uses of force
- Transit Police Department (parking lot) 2 uses of force
