This Special Meeting of the VIA Metropolitan Transit Board of Trustees (Board) will be conducted as a meeting/videoconference call at 3:00 p.m. on April 11, 2023. Each speaker is allowed a maximum of three minutes to address the Board and are requested to first state their name and any organization(s) they represent. All comments must concern only items that appear on the meeting agenda and shall be addressed to the Board as a body and not to any employee, staff member or audience member. A speaker may address the Board by using **one** of the following methods:

**To Speak in Person**

Speakers who wish to address the Board in person must register to speak. In person registration will be held at the VIA Metro Center Board Room, 1021 San Pedro beginning at 2:30 p.m. and ending at the start of the meeting.

**To Speak Online or By Phone**

Speakers who wish to address the Board live on-line or live by phone must register to speak.
