

NOTICE OF PUBLIC HEARING  
OF THE

CONCERNING ITS CONTEMPLATED ISSUANCE OF

VIA METROPOLITAN TRANSIT ADVANCED TRANSPORTATION DISTRICT  
SALES TAX REVENUE BONDS, SERIES 2024

Pursuant to Section 451.702(1-1), as amended, Texas Transportation Code (the *Act*), NOTICE IS HEREBY GIVEN that a public hearing will be held by the Board of Trustees of the VIA METROPOLITAN ADVANCED TRANSPORTATION DISTRICT (the *ATD* or the *Issuer*), at 3:00 p.m. on Tuesday, July 16, 2024, at the VIA Metro Center (*VMC*) Board Room located at 1021 San Pedro, San Antonio, Texas 78212, with respect to the contemplated sale and issuance by the Issuer of up to \$175,000,000 in principal amount of “VIA Metropolitan Transit Advanced Transportation District Sales Tax Revenue Bonds, Series 2024” (the *Bonds*).

The Bonds will be issued for the purpose of providing proceeds to the ATD to be used, when added to other funds lawfully available for such purpose, to (i) finance costs of designing, constructing, acquiring, improving, and equipping an Advanced Rapid Transit North/South Corridor Project (Green Line) (the *Project*); (ii) pay capitalized interest on the Bonds; and (iii) pay costs of issuance of the Bonds, all as permitted by and in accordance with the provisions of Subchapter O, Chapter 451, as amended, Texas Transportation Code. The Bonds will be payable from the proceeds derived by the ATD from the portion of the ATD sales and use tax (the *ATD Sales Tax*) approved at an election held on November 2, 2004, and available to the ATD to be used for such purpose. Upon completion, the Project will be owned and operated by the VIA Metropolitan Transit Authority.

All interested persons are invited to attend the hearing to express their views with respect to the Project or the issuance of the Bonds. In lieu of attendance at the meeting, written comments may be submitted to the Issuer. Further information with respect to the proposed Bonds will be available at the hearing or upon written request prior thereto addressed to the Issuer.
