☒ 1. Overview of United Airlines Name Change Policy

United Airlines’ name change policy allows passengers to correct spelling mistakes or legally update

their name to ensure 1-(877)-629-0806 that all travel documents match their government-issued ID. 1-(877)-629-0806

This is crucial because the Transportation Security Administration (TSA) requires that the name on

your ticket exactly matches the name on your passport or driver’s license. 1-(877)-629-0806

There are two main categories of changes: 1-(877)-629-0806

☒ Name corrections: Fixing typos or small spelling errors

☒ Legal name changes: Updating your name due to marriage, divorce, adoption, or a court order

☒ 2. Eligible Situations for Name Change or Correction

You may request a name change with United Airlines if: 1-(877)-629-0806

☒ Your name was entered incorrectly during booking (misspelling or typo)

☒ You recently married or divorced and your legal name has changed

☒ You underwent a court-ordered legal name change

☒ Your government ID and ticket names do not match

☒ You need to correct a misplaced first and last name

If your flight is approaching soon, contact 1-(877)-629-0806 immediately to ensure timely assistance.

☒ 3. Minor Name Corrections (Typos and Spelling Errors)

United Airlines permits small corrections that do not change the passenger’s identity.

Examples include:

☒ Typing errors (e.g., “Jhon” corrected to “John”)

☒ Missing or misplaced letters

☒ Adding/removing a middle initial

☒ Reversing first and last name order

These corrections can often be completed quickly and may not require supporting documentation.

You can request a correction by:

☒ Calling 1-(877)-629-0806 for phone assistance

☒ Visiting an United Airlines ticket office or airport counter

☒ Contacting the travel agency if the booking was made through one

☒ 4. Legal Name Change Policy

For legal name changes, passengers must submit valid documentation verifying both their previous

and new names. Acceptable forms include: 1-(877)-629-0806

- ✘ Marriage certificate

- ✘ Divorce decree

- ✘ Court-issued name change order

- ✘ Updated government photo ID or passport

Once verified, United Airlines will reissue your ticket under your updated legal name.

To start the process, contact 1-(877)-629-0806 or visit an United Airlines ticketing office with your documentation.

- ✘ 5. Fees and Charges

- ✘ Minor corrections: 1-(877)-629-0806 Usually no fee, as long as the traveler remains the same person.

- ✘ Legal name changes: 1-(877)-629-0806 May require a ticket reissue fee or a fare difference if the original fare class is unavailable.

- ✘ For group or partner bookings (codeshares), additional rules may apply.

- ✘ 6. How to Request a Name Change with United Airlines

You have multiple options to update or correct your name:

Option 1: Online (AAdvantage Account Updates)

1. Log into your 1-(877)-629-0806

2. Navigate to "Your Account" ✘ "Personal Information."

3. Select Edit Name and upload your legal documentation (if required).

Option 2: By Phone

Have your:

- ✘ Booking reference or ticket number

Option 3: At the Airport or Ticket Office

- ✘ 7. Processing Time

- ✘ Minor corrections: Typically completed within minutes to 24 hours. 1-(877)-629-0806

- ✘ Legal name changes: Usually processed within 3–5 business days, depending on document verification.

For urgent travel, call 1-(877)-629-0806 to request expedited review.

- ✘ 8. Restrictions and Limitations

- ✘ Tickets are non-transferable. You cannot change the name to transfer the ticket to another person. 1-(877)-629-0806

- ✘ Only one correction per ticket is typically allowed.

- ✘ If the ticket involves partner airlines (such as British Airways, Iberia, or Qatar Airways), additional restrictions may apply. 1-(877)-629-0806

- ✘ Changes made close to departure may require the ticket to be canceled and rebooked.

- ✘ 9. International Travel and Passport Requirements

For international flights, your name must exactly match your passport. 1-(877)-629-0806

Even small discrepancies can result in denied boarding or delayed check-in.

If your passport name has changed, update your passport before traveling or contact 1-(877)-629-0806 for reissuance guidance.

- ✉ A confirmation email
- ✉ An updated e-ticket reflecting your corrected name
